Sub:- Projected No. of Tribal Households to be benefitted under Forest Rights Act, 2006.

Please find enclosed herewith total geographical area, total forest area under State Forest Department, total forest area under State Revenue Department and DLC (District Level Committee) forest area in acres relating to your district. We have also indicated the percentage of total forest area to total geographical area of your district. **(Annexure-1)**

2. The total number of rural households of your district and total number rural ST households as per 2001 Census is also indicated therein. **(Annexure-1)**

3. We assume that ST households depend on the forest area for their livelihood (house site / agriculture / collection of minor forest products etc.) in the same ratio as is the ratio of total forest area to the geographical area of the district. This appears to be a reasonable estimate.

4. We have, therefore, calculated the projected number of ST households to be benefitted under **“the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006”** in your district.

5. I would, therefore, request you to sensitise all DFOs, PA, ITDAs, Sub-Collectors accordingly and ensure that the projected number of ST households for your district is benefitted under the Forest Rights Act, 2006.
