During the video conference on 29.01.2010 and 30.01.2010, it was surprising for us to find the following:-

- 1.** Sketch Map of land is not being given along with Patta in districts like "Deogarh" under the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights Act) 2006. (Though permission has been given for engagement of retired R.I. / Amin and purchase / use of handheld GPS for this purpose). This is a sorry state of affairs. This is in violation Rule-6 (e), Rule-11 (2) (ii) and Rule-12 (1) (e) of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Rules, 2007.
- 2.** Orders / Resolutions of Gram Sabha, Sub-Divisional Level Committee (SDLC) and District Level Committee (DLC) have not been communicated to the concerned claimants inspite of instructions of Chief Secretary vide Letter No. 6061 Dated 04.02.2009 (Para-3 and Para-9) and D.O. Letter No. 36829 / CS dt. 20.10.2008. We have advised Collectors to ensure dispatch of xerox copies of the above orders / resolutions to the claimants under certificate of posting.
- 3.** The above violations will invite criminal action against members of SDLC and DLC under Section 7 of the Scheduled Tribes and other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.
- 4.** All Collectors should be advised accordingly and remedial steps should be taken by them forthwith. Compliance of the above should be sent to you by all Collectors of your Division with copy to ST & SC Development Department.


