	4. Programme for holding Gram Sabhas in the scheduled areas of the State was issued and the Gram Sabha have started meeting from 28.2.2008. So far, out of 6024 villages in the scheduled areas, Gram Sabhas and FRCs have been formed in 5569 villages.
	5. Panchayat Department had requested the Gram Sabhas to meet around 25 th March, 2008 to issue calls for acceptance of claims. Gram Sabhas were held in March-April and dates of acceptance of claims were declared. So far 33,185 individual and 425 community claims have been received at FRC level.
	6. Formations of Forest Rights Committees have been completed
	7. Master Trainers for training the members of FRC have been identified and Tribal Research and Training Institute (TRTI) have started training the Master Trainers. Training of 267 Master Trainers has been completed. Sub-Division level stakeholders have also been trained. Competent individuals and organizations have started training women SHGs in tribal areas and awareness generation was created. Total 3500

persons have been trained.

- 8. One lakh claim forms have been printed by the Government Press and have been sent to FRCs. Individual as well as community claims have started pouring.
- 9. Awareness generation material along with a small booklet on frequently asked questions have been developed for free distribution in the villages.
- 10. Guidelines, templates, formats and checklists have been developed in consultation with few experienced collectors.
- 11. A sensitization workshop was held on 24.2.2008, wherein Act and Rules were discussed clause-wise and clarifications offered. Another workshop to discuss issues at field level was held on 26.4.2008
- 12. A meeting with various departments was organized on 25.4.2008. The departments have been instructed to identify their need for forest land for providing infrastructural facilities under Section 3(2) of the Act. The issue relating to all-weather road connectivity in tribal areas has been referred to the concerned department to find out solutions under Section 3(2) of the Act. Guidelines have been developed and circulated to the concerned departments to solve the matter.
- 13. Concerned Departments have been instructed to identify their nodal officer at District level for providing information and documents to the FRCs and for accepting notices from them.
- 14. 40,600 claims have been received.
- 15. Programme of monitoring, web-based, developed. Four films have been made and being beamed through DD Gujarati.
- 16. For implementing the Act and monitoring the implementation process, an independent cell, headed by Joint Director under the Commissioner, Tribal Development has been set up. This cell will also coordinate working of other departments and carry out IEC related activities.
- 17. Monitoring format for implementation of the Act has been developed and the programme is being monitored every week. A Core Group headed by Secretary, Tribal Development has been set up on 8.4.2008 to review weekly progress and develop IEC plans.

	18. A booklet containing 88 FAQs and A booklet containing guidelines in vernacular language have been printed in 10,000 copies each and distributed to FRCs. Typical phrases ,words and definitions translated and explained in English and Gujarati have also been circulated to the stakeholders up to Sub –Divisional level. areas, cultural troupes have been sent for awareness through songs and street plays. Workshops to sensitize the media have been organized at Indore ,Bhopal , Gwalior and Ujjain . One NGOs' workshop has been held inBhopal on 28 April 2008. More media workshops planned, 21 May at Rewa and 26 May at Jabalpur .

- 5. The second meeting of the State Level Monitoring Committee chaired by the Chief Secretary was held on 17th June, 2008. All decisions taken in the first meeting on 4th March, 2008 have been fully complied with.
- 6. Training of 2886 sub division level committee members and master trainers completed by April 30, 2008. All the members of District Level Committees have been trained by 31st May, 2008. Special training of Member Secretaries of district and sub division level committees has also been completed during 5-12 June, 2008. The forest department, I.T. division has held training in five batches of master trainers for operating Personal Digital Assistant.
- 7. Clarification on "primarily reside in and who depend on the forest or forest lands" vide MOTA letter of 9th June, 2008 has been circulated to all districts and collectors have been informed on 18th June, 2008 through video conferencing.
- 8. Gram Sabha meetings have been organized and 8 lakh claim forms have been distributed.
- 9. A total of 2.53 lakh claims have been received in the State and approximately 5000 title deeds have been distributed.
- 10. Land survey with PDA has been started.
- 11. State Government has budgeted Rs. 23 crore for carrying out the Act.

- 4. Translation of the Act and the Rules in Marathi, Korku, Bhillori and Gondi languages has been done. Bound copies of Acts and Rules in Marathi are under publication by the Government Printing Press. The applications forms are also under publication by the Government Printing Press.
- 5. District level training has been started. Some of the NGOs

	working in the field have also been trained. They are giving presentation to tribals in Marathi. 6. Awareness creation meetings of the representatives of the Panchayat Raj Institutions, and field functionaries, including the field staff of various Departments, were organized in various parts of the State. Sufficient copies of the Acts and Rules in local language have been distributed in the Awareness training programmes at the field level. An awareness campaign utilizing Air India Radio services has been initiated in the month of March 2008. Radio jingles being broadcast are in local language. The Publicity of the Act is also being done by putting up posters on the State Transport buses plying in the tribal areas. Publicity through advertisement in local newspapers is also being given from time to time. A film "Dream of Soma" has been produced and distributed. 7. All forest villages in Maharashtra have been converted into revenue villages. 8. About 75,000 claims have been received. Work of verification of the claims has started from June 2008 and, by September, titles are expected to be given.

- 6. Order was issued to conduct gram sabha in each revenue village in Scheduled Area and in each gram panchayat in outside Scheduled Area from 8th April to 17th April, 2008.
- 7. Gram Sabhas have been conducted in 4718 revenue villages against 4718 villages in scheduled area. 4718 FRCs have been formed in Scheduled Area. Most of forest area covered in Scheduled Area.
- 8. Gram Sabhas have been conducted in 3510 gram panchayats against 8211 panchayats in outside scheduled area. FRCs have been formed in 3082 gram panchayats.
- 9. Outside the Scheduled area many districts do not have much forest land and scheduled tribes population.
- 10. Sufficient number of claim forms have been printed and made available to the applicant.
- 11. Claims have already been called by Gram Sabhas. 34370 claims have been received by FRCs so far.
- 12. 3634 claims have been verified by FRCs and submitted to Gram Sabha. 3634 claims have been recommended by Gram Sabha and sent to SDLC. 883 claims have been verified by SDLC and sent to DLC. 136 claims have been approved by DLC which include 135 individual claim and 1 community claim total area of approved claims is 49.18 Hect.
- 13. Process of distribution of title is going on. No claim has been rejected so far at the level of DLC.
- 14. District Collectors have been directed to make available progress to PROs on regularly on monthly basis.
- 15. Panchayati Raj Department's Gram Sahayaks are being engaged as facilitators.

Action Taken Report on the actionable points for the States and Central Ministries for implementation of the Scheduled Tribes and OtherTraditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 approved in the meeting held in Prime Minister's Office on 21.1.2008

Ministry of Tribal Affairs

- 1. States/UTs have been addressed on 25.2.2008 to furnish State-wise information/data, such as, status of formation of various Committees, translation of the Act and the rules into regional languages and arrangements made for their distribution to Gram Sabhas, Forest Rights Committees, steps taken for creation of awareness about the objectives, provisions and procedures under the Act and the Rules, arrangements made for the training of PRI officials, SDLC/DLC members by the State Nodal Agency at State, District and Sub-Divisional levels, etc.
- 2. NIC has been entrusted the job relating to preparation of a comprehensive web-based information system for implementation and monitoring of the Act. The said system is likely to be finalised and put in place shortly.
- 3. Action is being taken for setting up an Implementation and Coordination Cell in the Ministry.
- 4. A pamphlet (in English and Hindi) on the Act in a reader-friendly format for wide circulation to the States and other stakeholders has been prepared and sent to PIB, DAVP, AIR, Doordarshan and DFP for organizing publicity campaign.
- 5. A meeting of Secretaries of Tribal Development/Welfare Departments of the States was organized by the Ministry on 18-19 February 2008 on the implementation of the Forest Rights Act. In the said meeting, the progress of implementation of the Act as also the issues raised by the States were discussed.

- 6. A number of writ petitions have been filed in different High Courts/Supreme Court against the Act. Necessary action to defend these cases is being taken.
- 7. The States/UTs have been addressed on 25.2.2008 to initiate necessary action for conversion of all forest villages into revenue villages in a time bound manner and to keep the Ministry informed of the progress made in this regard. Simultaneously, the Ministry of Environment & Forests have also been requested to initiate action, after individual rights have been vested, for conversion of 2474 forest villages/habitations in 12 States into revenue villages and any other such habitations as per provisions of Section 3(1)(h) of the Forest Rights Act, 2006.
- 8. A Core Group consisting of representatives of Ministries of Panchayati Raj, Law & Justice and Environment & Forests as Members has been formed under the Chairmanship of Secretary(Tribal Affairs) for taking a view on queries and references from State Governments.

Ministry of Environment & Forests

The Ministry of Environment & Forests, vide their O.M. dated 14.3.2008, has suggested to this Ministry a procedure to be followed for seeking prior approval for diversion of forest land for non-forest purposes for facilities managed by the Government under Section 3(2) of the Act. The same is under examination by the Ministry.

Ministry of Panchayati Raj

The Ministry of Panchayati Raj has addressed the Chief Secretaries/Administrators of all States/UTs on 15.2.2008, suggesting that all the States may organize Gram Sabhas on 28.2.2006 during which the provisions of the Act and the rules and the roles and responsibilities of PRIs, Gram Sabhas and FRCs be explained.

Ministry of Information & Broadcasting

Ministry of I&B had requested this Ministry on 24.1.2008 to provide software/publicity content to PIB, DAVP, AIR and Doordarshan for providing media support to the implementation of the Act. The same was provided to these media units on 8.2.2008. Subsequently the said publicity material was also provided to the Directorate of Field Publicity on 7.4.2008.
