Status report on implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 [for the period ending 31.3.2020]

Readiness of the States in the implementation of the Act:

- (i) An updated status of State-wise implementation of the Act is given in **Annexure-I**. As per the information collected till now, **42,51,545 claims (41,02,437 individual and 1,49,108 community claims) have been filed and 19,83,504 titles (19,07,126 individual and 76,378 community claims) have been distributed.**
- (ii) A total of 37,36,057 (87.88%) claims have been disposed of. It may be seen that there is decrease of 3600 claims being shown as disposed off in March, 2020 cumulatively compared to the previous month. The number of disposed off claims are seen to decrease only in Odisha. The reasons for the same were obtained from the State Government which has clarified that claims rejected earlier are under review and therefore, the number of claims disposed of has decreased.
- (iii) A statement on claims received and distribution of title deeds in various states, as in **Annexure-II**, is being maintained.
