Status report on implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 [for the period ending 31.08.2019]

Readiness of the States in the implementation of the Act:

- (i) An updated status of State-wise implementation of the Act is given in **Annexure-I**. As per the information collected till now, **42,39,391 claims (40,90,565 individual and 1,48,826 community claims) have been filed and 19,69,426 titles (18,93,265 individual and 76,161 community claims) have been distributed. A total of 37,22,270 (87.80%) claims have been disposed of.** A statement on claims received and distribution of title deeds in various states, as in **Annexure-II**, is being maintained.

18	Nagaland	-	Government of Nagaland informed that in the State of Nagaland, the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 is not applicable in view of the provisions of Article 371 A of the Constitution which gives special status to the State of Nagaland with regard to the rights of the people over land and its resources. The inhabitants of the State are predominantly tribal with distinct linguistic, culture, tradition, customs and socio- political characteristics and also the land and Forests belongs to the private individuals, clans or community in the villages and land holding and resources therein are governed by traditional and customary practices of the people. That the said Article also specifically provides that No Act of Parliament in respect of ownership and transfer of land and its resources, shall apply to the State of Nagaland unless the Legislative Assembly of Nagaland by a resolution so decides. That in view of the said provision of the Constitution, there is no resolution passed by the Legislative Assembly to make the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006 applicable to the State of Nagaland
