

Right & Concessions :

56. No rights exist in the A class M.F.s while certain concessions are allowed to the cess paying rayats of the Ex-state as indicated in the Appendix -IX at page 131 of the Report of the Forest Enquiry Committee, 1959 published by the defunct Development Department of Government of Orissa which is reproduced below :-

In "A" Class Reserved Forests :

57. No rights exist in the A Class Reserved Forests but certain concessions as indicated below are granted in special cases :-

Timber :

Free to cess payers with previous sanction if not available in Khesra Forests.

Fire wood: N I L.

Bamboo :

Free with permission if not available in Khesra Forests.

M.F.Ps. :

Fibre free if not available in the Khesra Forests (with permission)

Aboriginal tribes, landless or poorer classes are allowed to remove fallen fire wood, bamboo, fibre, fibres, leaves and grasses, honey and wax for the purpose of sale on payment.

Rs. 0.2-0	per acre on wet land royalty

Rs. 0.4-6	per acre of Goda land Lakhrāj

Chandan Cess: Rs. 0.4-0 per house and hold.

Hadis, Damba, and other tribes are permitted to take bamboo on payment and kundras are permitted to remove trees for making combs and other articles on payment of royalty.

The aboriginal tribes are permitted to remove edible fruits, roots, flowers and leaves on free of royalty for their own consumption.

Grazing :

No free grazing. The rates for grazing has been fixed.

In "B" Class Reserved Forests :

(also in D.F.Fs.)

Timber :

58. Timber is to be supplied free to the cess paying villagers living in villages situated within a convenient radius of the B class Reserved Forests. Timber for agricultural implements to be supplied free from this type of R.Fs. according to a fixed scale. Excess over the scale may be allowed at $\frac{1}{2}$ schedule of rate.

Fire wood :

Allowed to the cess paying villagers as free as per the prescribed scale. Any excess over the scale is charged at $\frac{1}{2}$ schedule of rate.

M.F.Fs. : Free.

Grazing :

No free grazing is allowed. Rates for tenants and professional graziers has been fixed.

In Kheara Forests or Unreserved areas of M.F.Fs. :

Timber :

59. Both reserved and unreserved species are to be given free to the cess paying tenants, while required for agricultural implement at $\frac{1}{2}$ of the schedule of rate is to be charged in case of reserved species when required for personal use. All pangs, indigenous tribes and poor and landless
