

**PROCEEDING OF THE MEETING ON CONVERSION OF FOREST VILLAGE/
UNSURVEYED VILLAGE INTO REVENUE VILLAGE HELD ON 28.08.2019 AT 03.30
PM IN THE SADBHABANA SABHA GRUHA COLLECTORATE, DHENKANAL**

The meeting on conversion of Forest Village/ un-surveyed village into Revenue village was held on 28.08.2019 at 03.30 PM under the chairmanship of Collector & D.M., Dhenkanal in Sadhabana Hall of Collectorate, Dhenkanal. Additional District Magistrate, Dhenkanal, with the Sub-Collector, Kamakhyanagar and Dhenkanal, Tahasildar Gondia, Parjang, Kankadahad, Kamakhyanagar along with the R.I.s, Forest Range Officers and Foresters were present. The State Co-ordinator "VASUNDHARA", Smt. Puspanjali Satapathy attended the meeting as Resource Person. The District Welfare Officer, Dhenkanal and the ADWO (Hqrs.) also attended the meeting. The participants present in the meeting is annexed as Annexure 'A'

At the outset the Collector welcomed all the participants and emphasized to complete the process of conversion within the stipulated time by utilizing the services of Revenue and Forest Dept. officials for preparation of map after identifying the village customary boundary. The ADM, Dhenkanal requested the Resource Person Smt. Satapathy to elaborate the different steps for conversion of Forest village into Revenue village through Power Point Presentation. The following steps required to be taken for conversion of Forest village into Revenue village.

STEPS TO CONVERT FOREST VILLAGE INTO REVENUE VILLAGE

- a) Step I- Identification of Forest village (Already identified)
- b) Step II- Issue of proclamation letter by District Collector.
- c) Step III- Circulation of letter to concerned Forest village (Already identified)
- d) Step IV- Formation of FRC (Action Tahasildars /BDO)
- e) Step V- Resolution by Gramsabha (Action Tahasildars)
- f) Step VI- Filling of claim form (Action Tahasildars /Forest Range Officer)
- g) Step VII- Demarcation of village Boundary by Forest Dept. Officials Revenue Deptt. Officials in presence of Gramsabha and FRC Committee.
- h) Step VIII- Submission of Gramsabha Resolution Map and Joint enquiry statement to SDLC(Action Tahasildars /BDOs)
- i) Step IX- Submission of decision of SDLC to DLC (Action Sub-Collector)
- j) Step X- After DLC, Post DLC approval, Collector to approve and submit to board of Revenue.
- k) Step XI- Forest village to be declared as per Odisha Survey and Settlement Act 1985 section 2, sub section 1.4.

The Resource Person appraised the participants through Power Point and explained the procedure and steps to be under taken for the process. Interfering in the discussion the Collector wanted to know from the Tahasildar and others about the present status of the 17 (seventeen) nos. Forest villages of Dhenkanal district. The Tahasildar, Kankadahad told that only one village 'Khuribhanga' out of 9 no of villages Kankadahad Tahasil has been approved in SDLC and all the parameter have been completed and needs to get approval in DLC. The Collector urged to start the work of rest 16 (sixteen) nos. of Forest villages without wasting further time with joint co-ordination of officials of Forest & Revenue Deptt. from 05.09.2019 which was accepted unanimously. As decided in the meeting the detaled program is given below.

Dt.05.09.2019 to 09.09.2019	Completion of all ground work such as visit of site Acquittance of places interact with villagers (Action: Tahasildars, Range Officers)
Dt.10.09.2019 to Dt.15.09.2019	Field work, Formation of FRC, Preparation of map after demarcation of village Boundaries, Plotting of Land, Segregation of Agr. Land, Homestead Land,
Dt. 16.09.2019 to Dt. 20.09.2019	-Holding of Gramsabha (All 16 villages) (Tahasildar/ BDO/R.I./Foresters/FRC)

The Sub-Collector Dhenkanal Sadar and Kamakhyanagar were requested to supervise the progress of work regularly. The Collector also requested the Resource Person of State Coordinator Vasundhara to extend co-operation upto completion of the entire process.

The meeting ended with vote of thanks to the chair and all members present in the meeting.
