Sir,

It has been decided to take up Nutri-Garden in 750 GPs of 107 Blocks in convergence of MGNREGS with OLM in the following manner. Model estimate of the Nutri-Garden is enclosed.

- The project will be implemented by OLM in 107 Blocks and 750 GPS as per the list communicated by OLM, covering 2.5 lakh HH.
- This will be provided to 2.5 lakh Individual Households as individual benefit project. The selection of beneficiaries shall be done on the basis of HH covered under paragraph 5 of Schedule-1 of MGNREGA i.e. SC/ST households, Rural Housing beneficiaries, BPL households, FRA beneficiaries, Small & Marginal farmers etc.
- Components of Nutri Garden:
