Dear Sir/Madam,

This is regarding the revision of Minimum Support Prices (MSP) of Minor Forest Produce (MFP) items under the scheme 'Mechanism for Marketing of MFP through MSP and Development of Value Chain' - MSP for MFP in short. As you may be aware, the exercise was last carried out by this Ministry in January 2019 wherein the MSP of as many as 49 MFP items had been revised / decided and notified. The Revised MSP rate list is also being enclosed herewith for your reference.

This Ministry has of late received certain recommendations regarding revision of MSP for certain MFPs from a few State MFP Agencies namely Chhattisgarh and Madhya Pradesh. As this Ministry declares MSP of MFP items for the whole country, it is felt that recommendations from all States/UTs need to be considered before revision of MSPs.

Accordingly, you are requested to forward the prevailing market rates of MFPs in your State along with recommendation of any new MFP item that need to be included for MSP fixation under the scheme. As the situation due to the outbreak of corona virus may have adverse effect on the livelihood of the already marginalized MFP gatherers, you are requested to submit your recommendations within one week through email.
