Sub: Resumption of Aadhaar enrolment activities - Regarding


Sir,

As you are aware, functioning of all Aadhaar Centers under OCAC Registrar have been suspended across the state since 20th March, 2020 with a view to contain the spread of novel Corona Virus (COVID-19) pandemic.

But, it is felt that, beneficiaries of various schemes as well as common citizens of the state are facing a lot of difficulties due to non-functioning of the Aadhaar Centres for such a long period. Hence, it has been decided to re-open the Aadhaar Centers at District/Block/ULB level with immediate effect by observing the precautionary measures issued by UIDAI vide their notification no. F. No.4(4)/57/122/2012/UIDAI/pt Dated 28 04.2020 (copy enclosed).

Therefore, it is requested that suitable instructions to Blocks/ULBs under your jurisdiction may please be issued at your end to re-open the Aadhaar Centers by observing proper sanitization and social distancing norms. DeGMs may please be instructed to co-ordinate with System Integrators and Aadhaar PMU of OCAC for mobilization of Aadhaar operators to their respective allotted centres.
