Status report on implementation of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 [for the period ending 31st May, 2009]

- - -

1. Regarding Court cases filed against the Act:

The Government of Andhra Pradesh filed an Interim Application in Andhra Pradesh High Court seeking direction from the High Court to issue certificates of titles or pattas to 1,14,329 eligible forest dwelling STs and other traditional forest dwellers of Andhra Pradesh. On consideration of the Interim Application, the Andhra Pradesh High Court passed an order on 1.5.2009 permitting issue of pattas to the eligible claimants of forest rights.

2. Readiness of the States in the implementation of the Act:

(i) An updated status of State-wise implementation of the Act is given in **Annexure-I**. Some of the States like Andhra Pradesh, Chattisgarh, Gujarat, Orissa, Tripura and West Bengal have already reached their almost full potential as far as collection of claims is considered. Therefore, the concentration in those States is on the process of actual issue of **Pattas.** As per the information collected from the States till 31st May,

2009, more than 21 lakhs claims have been filed and about 1.66 lakhs titles have been distributed. More than 1.89 lakhs titles are ready for distribution. Pending population of the web-site (www.forestrights.gov.in), a statement on claims received and distribution of title deeds in various states, as in Annexure-II, is being maintained. Both Annexures I and II are also being put up on the Ministry's web-site.

(ii) This Ministry has been persuading States/UTs to populate the web-site for (www.forestrights.gov.in), the effective monitoring of the implementation of the Act. The nodal officers of the States/UTs for the implementation of the Act have also been trained by the NIC and Director of this Ministry also interacted with them through Vidieo Conferencing. However, only five States (Andhra Pradesh, Madhya Pradesh, Orissa, Rajasthan and Tripura) are uploading on to the website. Secretary, Tribal Affairs has again urged all the Chief Secretaries/Administrators of States/UTs on 21.05.2009, demi-officially, to start uploading the relevant information relating to the implementation of the Act on to the website.

4. <u>Matters relating to the Act pending at the level of Government of India:</u>

The procedure for diversion of forest land for facilities managed by the Government under section 3(2) of the Forest Rights Act 2006, has been issued on 18th May, 2009. The same has also been uploaded on the Ministry's web-site. All the State/UT Govts have been advised to direct the Nodal Agencies to take immediate steps for giving wide publicity to the procedure and to bring the same to the notice of all the Gram Sabhas in their States/UTs. No other matter relating to the Act is now pending at the level of Government of India.
